The novel coronavirus (COVID-19) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. Texas Governor Greg Abbott has allowed Summer Camps to re-open on May 31, 2020. As such, Straight Arrow Clubs & Camps, Inc., henceforth, referred to as "SAC", has decided to conduct our summer camp, in accordance with these executive orders. SAC has put in place preventative measures to reduce the spread of COVID-19 during camp. However, SAC cannot guarantee that any camper will not become infected with COVID-19. Further, attending summer camp could increase the risk to your child of contracting COVID-19. Attendance at this summer camp is completely voluntary. We should all be thankful that, with rare exceptions, COVID-19 is not claiming the lives of our children. However, we can never forget that a child with a mild or even asymptomatic case of COVID-19 can spread that infection to others who may be far more vulnerable. (Reference, Minimum State Health Protocols, dated May 18, 2020) Because of this, we recommend that your child be restricted from visiting with friends or family members over the age of 65, for 14 days, following their week at camp.

SAC Rules and Regulations for Summer Camp

_____ I fully understand and agree to full compliance with all of the following Rules and Regulations for my
Initial camper _____.

- All Campers/Staff must complete the Certification and Participation Waiver and Release and provide the signed form in order to be granted admission to the Camp.
- No Parents/Guardian allowed past the Registration House. No Visitors allowed on the Camp Property.
- All Staff and Campers, before attending, upon arrival, and at least once daily while at camp, will be screened for any of the following new or worsening signs or symptoms of possible COVID-19: cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, feeling feverish or a measured temperature greater than or equal to 100.4 degrees Fahrenheit, or known close contact with a person who is lab confirmed to have COVID-19.
- If your child/camper shows any of the above symptoms during camp. The camper will be quarantined and parents will be notified to **PROMPTLY** pick up camper.
- **No outside food or drinks permitted in the camp kitchen or trading post.**
- All campers and staff must meet with the Camp Medical Team prior to admission into camp buildings. The Medical Team will take temperature and assess health and sign off for admission to camp.
- Individuals with underlying health conditions and individuals aged 65 or older are at higher risk of COVID-19. It is recommended that high-risk campers and staff, including individuals with other health conditions or individuals aged 65 or older, refrain from attending camp or avoid being within 6 feet of any other individuals.

_____ I agree and certify to all of the following statements for my camper, _____,
Initial

- At the time of Registration, myself and child/camper has not been lab confirmed and/or am not waiting for a lab confirmation that my child/camper has COVID-19.
- At the time of Registration and for at least 7 days prior to Registration, my child/camper has not experienced any of the following signs or symptoms of possible COVID-19: cough, shortness of breath, difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste, loss of smell, diarrhea, feeling feverish or a measured temperature greater than or equal to 100.4 degrees Fahrenheit.
- At the time of Registration, my child/camper will have their temperature checked by the Medical Team. My camper will be checked for temperature each day.
- At this time of Registration, my child/camper has not had close contact with a person who is lab confirmed to have COVID-19 within the last 14 days.
- My child/camper agrees to follow the SAC Rules and Regulations for Summer Camp.

If you cannot agree and certify to ALL of the above statements for your child/camper, up until the time of the ceremony, the child/camper cannot certify to all of the above statements **MAY NOT ATTEND THE CAMP.**

ASSUMPTION OF RISK/WAIVER AND RELEASE OF LIABILITY/INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate in summer camp at Straight Arrow Camp, the undersigned acknowledges, appreciates, and agrees:

1. I acknowledge the contagious nature of COVID-19 and agree that participation and attendance at summer camp includes possible exposure to and illness from COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist, and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown for my child/camper. EVEN IF ARISING FROM THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF OTHERS (including SAC volunteers, agents, or Board Members as well as other campers) and assume full responsibility for my child's participation and attendance; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation of camp as regards protection of infectious diseases. If, however, my child/camper experience any unusual or significant illness during their camp week, they will be isolated and I will be contacted immediately and will come to pick them up to be checked out by a Medical Professional Facility, and bring such to the attention of the nearest official immediately; and
4. I, for myself, my child/camper, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, COVENANT NOT TO SUE, AND HOLD HARMLESS STRAIGHT ARROW CAMP, their officers, board members, officials, agents, and/or volunteers, and, if applicable, owners and lessors of premises used to conduct the camp ("RELEASEES"), WITH RESPECT TO ANY AND ALL CLAIMS FOR ILLNESS, DISABILITY, DEATH, or loss or damages of person or property, WHETHER ARISING FROM THE ACTIONS, OMISSIONS, AND/OR NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I understand agree that this release includes any claims based on the actions, omissions, or negligence of the Releasees whether a COVID-19 infection and/or any resulting illness occurs before, during, or after the summer camp.

I HAVE READ AND CERTIFY TO ALL THE STATEMENTS IN THE CERTIFICATION, I HAVE READ THE ASSUMPTION OF RISK/WAIVER AND RELEASE OF LIABILITY/INDEMNIFICATION AGREEMENT, I FULLY UNDERSTAND THE TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN BELOW FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
